C. Cooper distributed a copy of the Annual Report to the State. D. Schwert made a motion to accept the report and was seconded by M. Dale. The motion was unanimously approved.

Alex Muto, the AmeriCorps worker will be leaving us early; March 23rd is her last day. She got a full time job at the Bethlehem Public Library in Albany. She begins there on March 28. K. Mostyn will be looking for a replacement.

Cathy Williams retired on February 25th after being at the library for 20+ years. The library staff threw a party and purchased a retirement gift for her.

M. Klepp would like to move the blue spruce on the side of the library. It has grown larger than the size there can handle. The board unanimously approved moving the blue spruce to another location on a motion made by M. Dale and seconded by S. O'Dea.
